It goes without saying, therefore, that our corporate objectives include environmental and energy goals.

In order to achieve these goals, we have introduced a certified energy management system in accordance with ISO 50001, as well as corporate processes designed to protect the natural environment and its resources. Our system is subject to a continuous improvement process that enables us to minimise our environmental impact and to improve our performance while protecting our natural environment.

We make sure that all our processes are as environmentally friendly and energy-efficient as possible, within an economically reasonable framework. For us, this means that the development of our products and services and the procurement of other products and services go hand in hand with an examination of sustainable improvements in energy-related performance. All logistics services performed by the Stiegelmeyer-Group itself or on behalf of the Group are carried out in close consultation with customers and suppliers in a way that is as environmentally friendly and energy-efficient as economically reasonable.

This continuous improvement process does not apply exclusively to our processes. Our plant and machines are also regularly inspected to make sure they are in good technical condition. This means that we are always on the lookout for safe, economically viable technical optimisations that improve energy efficiency and reduce the environmental impact. Our energy monitoring system enables us to record energy consumption and thus to measure and evaluate any measures implemented within the framework of our environmental and energy management system.

As implementers of our environmental and energy policy, our employees and managers take part in regular training and further education. This enables us to keep employees up to date on the efficient use of energy and resources and regarding new statutory regulations. It also motivates them to actively pursue our energy and environmental goals.

The Stiegelmeyer-Group is very aware of its obligations, which is why we conduct regular audits to ensure compliance with applicable statutory regulations and other requirements. These audits also help us to identify and evaluate environmental and energy-related aspects of processes, services and products. This allows us to continuously check, re-evaluate and adjust our environmental and energy goals and associated measures.

To this end, the management undertakes to provide the necessary financial and human resources and the information required to achieve the strategic and operational goals, provided that our environmental and energy policy is appropriate with regard to the type and extent of energy and resource utilisation and consumption.
